उपरोक्त विषयाबाबतच्या संदर्भाधिन अनुक्रमांक ३ येथील शासन पत्राच्या अनुषंगाने आपणास कळविण्यात येते की; आपल्या कार्यालयाच्या दिनांक दि. ४ जुलै २०१४. च्या पत्रामधील मुद्यां क्रमांक ४.१ बाबत अतिरिक्त स्वरूपात नमूद करण्यात येते की, मुंबई अग्नीशमन अधिकारी, मुंबई यांचे दिनांक १८.६.२००७ च्या पत्रानुसार मुंबई अग्नीशमन विभागाचे ना-हरकत प्रमाण पत्र दिलेले आहे. सदर प्रमाणपत्राचे अवकलोकन केले असता शाळेची इमारत प्लॉट नंबर सीटीएस/डी/५१४(पीटी), डी/५१९ (पीटी) आणि डी/५२०/(पीटी) व्हिलेज बांद्रा, गोविंद पाटील रोड, बांद्रा पश्चिम, असा दिलेला आहे. सदर पत्रा आणि हल्लीच शिक्षण निरीक्षक यांनी शाळेस दिलेल्या नमुना २ मधील तात्पुरते मान्यता प्रमाणपत्र याचे एकत्रित रित्या अवलोकन केले असता असे स्पष्ट होते की, सदर शाळा ही मुंबईतील गोविंद पाटील मार्ग, खार दांडा, खार पश्चिम, मुंबई- ५२ येथील असल्याचे स्पष्ट होत आहे. यावरून संस्थेने त्यांची शाळा ही खार पश्चिम येथे असल्याबाबतच्या म्हणण्यामध्ये तथ्य दिसून येत आहे. म्हणून खार येथील पत्यावर सदर संस्थेला CBSE चे ना-हरकत प्रमाणपत्र देण्यास कोणतेही कायदेशिर अडचण दिसून येत नाही.

तसेच संस्थेने ICSE ऐवजी CBSE ना-हरकत प्रमाणपत्र बाबत मागणी केलेली आहे. त्याबाबत आपल्या स्तरावर उचित निर्णय घेण्यात यावा.

I am directed to forward herewith the application along with enclosures in original received from "Rizvi Springfield School, Govind Patil Marg, Khar Danda, Mumbai 400 052" run by "Rizvi Education Society, Rizvi House, 1st Floor, Junction of Hill Road & St. Martin Road, Bandra, Mumbai-400 050" and to state that this authority renews ~~the~~ No Objection Certificate to accord affiliation to the school for classes from Std. I to XII subject to fulfillment of various conditions laid down in the G.R. No. NOC 2009/(663/09)/SE-1 dated 20/6/2012 as well as following conditions:-


- 1) Like all other schools in the State, Section 18 & 19 of the Right to Education Act, 2009 and its schedule as well as rules and orders issued by State Government from time to time under this Act will also be applicable to the said school. They should abide by the State Government Acts, Rules, Regulations and Orders issued from time to time.
- 2) Institution is abide by the provision made in the RTE Act, 2009 and Maharashtra RTE Rules 2013 (Manner of 25% admission) for 25% reservation regarding admission for weaker section and Disadvantaged group.
- 3) Institution is abide by the policy and Maharashtra Education Institution (Fees Regulation) Act, 2011 made by the State Government regarding regulation of fees.
- 4) Curriculum of the State or respective Board will be compulsory from Std I to V.
- 5) Marathi language subject will be taught upto Std. VIII.
- 6) Staff salaries should be paid as per Govt. Scale.
- 7) No one should demand donations under Maharashtra Educational Institutions (Prohibition of Capitation Fee) Act, 1987 either from the students or from parents.
- 8) It will be mandatory for the school to provide information about the details of classes and number of students to Education Officer (Primary & Secondary) filling in UDISE or other databases as required by Department from time to time.
- 9) The management shall follow the traffic and safety guidelines indicated by the Police, Fire Services and Transport Department from time to time. The instructions issued in Circular Memo No. 21748/DI/97, dated

16/2/1998 and No. PRE-2008/506/11/Prashi-1 dated 14/7/2011 & other orders of transport department for safe transportation of school children should be scrupulously followed.

- 10) The management should provide fire protection arrangement as prescribed in the National Building Code of India, Part-IV Fire 1997 and it's amendments from time to time.
 - 11) The State Government reserves the right to carry out academic/audit inspection of the school.
 - 12) The State Govt. reserves the right to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules is reported found in future and the management fails to comply with the instructions of the State Government.
2. You are requested to forward a copy of the affiliation when granted to the above school to this office.

This renewal of NOC is issued as per the powers delegated by the Government vide School Education & Sports Department Government Resolution No. EST 3814/CR 123/14/PRASHA-2, Dt. 02/05/2014.
